#### **New Business**

How do WE see reopening of play for NCASA?

Questions around liability main concern looking at Phase Two and moving towards Phase Three Looking for central guidance – US Soccer, USASA and insurance

Age Discrimination – Example – league normally offers aged division but decides to close aged divisions due to COVID, is the league violating players

First guideline is to follow NC Government guidelines

Social Distancing

Mass gathering rules and definition

Which activities will insurance cover?

Collective conversations with league leaders - cover many topics, jerseys, managing sidelines, etc.

"At this point in time" decisions - standards NCASA should advocate

JM - states NC may move into Phase Three prior to NCASA next meeting

Phase Two - 2-3 weeks

Phase Three - 4-6 weeks

SE - makes a motion to move NCASA June 15<sup>th</sup> meeting to June 8<sup>th</sup> to consider Gov. Cooper announcement regarding Phase Three.

JM – seconds

Motion passes unanimously

NCASA will meet June 15th instead of June 8th

Region III National Cup

Tournament is suspended – NO National Final Four

Event may happen with different focus

Carolinas Cup Champions and Finalists will NOT receive travel subsidy

(travel subsidy is to assist with National Cup pursuits)

In normal times, NCASA Champions and Finalists receives travel subsidy after Team Bond has been submitted and travel plans have been secured

## **Unfinished Business**

USSF, USASA, NCASA actions in response to Coronavirus outbreak (Scott; Darius)

Review of communication received – most leagues are in lockdown – many NC captains are still hoping the Region III event happens this summer.

Review of communication to leagues – have been centered around the question of returning to play.

NCASA Safe Sport Policy actions

Communication with USSF – USASA meet with US Soccer legal council to create a "Recommended Guidelines for States"

USASA Guidelines discussed – states, like NCASA; that do not register U18 players but have travel teams:

- 1. Each League director and NCASA board should take the course.
- 2. All travel teams must have one designated individual that takes the Safe Sport course and have a background check.

NCASA questions the thoroughness of these guidelines; enforcement, background checks and logic. NCASA wants a more concrete answers before establishing a policy. USASA's guidelines took too long and are too thin.
