### **New Business**

- USASA Annual General Meeting Postponement USASA AGM has been postponed until Feb.to coincide with the US Soccer AGM.
- New Waiver USASA and AG Insurance have provided the language to be added to the current USASA Release of Liability Waiver to address the coronavirus'
- COVID-19 Waiver Darius will provide the board with a COVID-1 specific waiver to consider
- Insurance Rebate USASA is working with its insurance company regarding rebate since there has been a long stretch of time of "No Play"
- New Statewide League Darius reviewed the importance of a statewide league to attract teams seeking a higher level of competition, including Hispanic teams, and to possibly attract UPSL teams. Jason expressed strong support for the idea and suggested that Scott appoint a single person to spearhead development of the league. Others echoed their support of the concept. No action was taken.
- Region III Event (Travel Subsidies) extended discussion around travel subsidy for the Carolinas Cup Champions and Finalists to attend the Region III event (which is not a National Cup event) Donna offered a motion: Carolinas Cup Champion and Finalist will not receive the travel subsidy to participate at the 2020 Region III "Soccer Is Life" <u>non-National Cup event</u> and the NCASA board strongly recommends that North Carolina teams not attend the event Bob seconded the motion Jason abstained from voting Motion passed.
- Alianza Cup USASA has sanctioned the Alianza Group as an affiliate, It is a private company that caters to the Hispanic soccer community. The affiliation might provide a positive connection in North Carolina between USASA/NCASA and unaffiliated Hispanic leagues.

- How do WE see reopening of play for NCASA? NCASA needs to designate an entire meeting to extended discussion on moving forward into the state's Phase III.
- USSF, USASA, NCASA actions in response to Coronavirus outbreak Darius will gather state and league information on steps for reopening and protocol for play

- Status of planning for NCASA Board Retreat Jeremy will be looking at possible dates for a retreat
