#### **New Business**

NCASA 2021 AGM Planning

SE - NCYSA organized 2021 AGM for Charlotte - NCYSA has shifted changed to Virtual

Option 1 – A one day AGM in person

Option 2 - Virtual

DL – suggests a virtual AGM

JM – maybe it is too early to call, NCASA are on a small scale. JM finds value in an in-person. Calls into question if we hold Carolinas Cup and then not hold an in-person meeting

SE – suggests an AGM Committee to explore Virtual vs a Single day AGM

BK – suggests delaying decision – inform all league members now what is being weighed – in person or virtual SE – DL, **JB**, BK to form the committee (JB Chair) to discuss the virtual meeting and AV, **JM**, SC (JM Chair) will work with the group addressing the in-person meeting

#### Spring 2021 Fees

Players/Leagues

March 1, NCASA paid USASA 4633 \$64,862.00

Some of the concerns are our Spring 2020 players have only played 1-2 games some 3-5

DL – is doing some analysis on the financial picture to begin to drive the discussion. DL will share her findings once there are more complete.

SC – recommends keeping the concepts separated, collecting for Spring 2021 is one and refunding because of the COVID-19 should be treated differently from Spring fees.
