Numbers have increased, currently 5970 players – 29 Tournament Only Passes – paid USASA 4633 2021 Affiliation Module is ready

SC - Revenue projections assumes NCASA will have a healthy bounce back

Competitions

Carolinas Cup (December)

DE – introducing Kevin Broadley, Carolinas Cup assignor for 2019 and 2020 – to share information about the referee program that serves the event.

KB – want referees to not only give back to the game but also compete to be part of the program. Coordinating referee assignors to have referees assigned by their strengths to the events across the state.

DE - Quality fields and quality referees are the top two concerns of our adult players.

Currently 20 teams registered

JB - discussed the COVID protocol the Carolinas Cup have put in place. Surpasses NC Fusion criteria

PJ – wants the CC committee to look into solutions to referees that are working the tournament.

SC – the protocol is very thorough, do spectators have a particular area? Explain post game behavior for players

DE – explained a staggering schedule that provided more time between matches, players are expected to leave after their match
