- Celebrate the Tatas On December 9<sup>th</sup>, Sam Cohen, Darius Ejlali and Cindy Morrison presented a \$15,000 donation to Atrium Health / Levine Cancer Institute in Charlotte, NC. The previous month, on Nov. 22<sup>nd</sup> NCASA also presented a \$15,000 donation to Novant Health Foundation. A total of \$30,000 donated for mammograms for the uninsured and under-insured.

#### **2022 NCASA Budget**

#### Old & New Business (discussions)

NCASA Constitution and Bylaws update intended to make Constitution & By-laws consistent (with each other and with USASA requirements) and to streamline/clarify language and make consistent with current operations; the update is not intended to make any significant substantive changes. The PURPOSE of the Constitution is to be a legal document that contains the fundamental principles according to which an organization is acknowledged to be governed, while bylaws are the rules an organization makes to control the action of its members.

Safe Sport Policy - NCASA continues to shape the Safe Sport Policy. USASA Governance Committee are drafting a USASA Policy and working on a state level policy template to help states. Based on what we have seen, the policy will require all NCASA Board members and the Board members of NCASA member leagues to take the SafeSport training.

Elections – Nomination Committee has contacted all the incumbents, and all are running except for the VP of Men's Competition. Deadline for nominations is January 7, 2022.
