Officer & Staff Reports

- President Voting on approving move to a player registration system. Mentioned registration system will have a cost associated with it which will be stated in the 2023 budget. There will be costs associated with player registration that will be paid by the NCASA in the amount of \$2.00 per player. There was a special council meeting to approve the new board positions. Brianna Pinto reached out to see how the Athletes Council can work with adult players. There was also a question about paying the US President a salary. A sports athletic company reached out and Sam asked they were willing to be a sponsor. They are interested in a follow up conversation. Rumor has it that the USASA Adult Soccerfest may be at Bryan Park next summer. The official announcement is 11/15.
- Executive Director Registration and Insurance have been big topics. Working with AG on claims and turnaround. Created a Celebrate the Tatas survey. There have been 16 responses to the survey. They are trying to get more responses before evaluating the results. A free agent list has been created for the Carolinas Cup. Working on awards description for the AGM. Sam has also spoken to someone in reference to the \$1 million tournament ("The Soccer Tournament") coming to Raleigh next summer.
- Executive Vice President Will be speaking about the registration system.
- Treasurer Significantly ahead of the budget from last year. That is mainly due to player registration.

Approval of Minutes

Minutes for the October 17, 2022, NCASA Board meeting were approved unanimously.

Growth Initiative

- Registration Report Approaching 12,000 players for the year. May reach that depending on tournament only registrations for Carolina Cup.
- Donna is on a USASA committee reviewing tournament-only passes and a new "welcome" pass
 for new leagues. USASA's review of tournament only passes is looking at issues such as: How
 many games, how many days does it last, cost, etc. NC and FL use tournament-only passes the
 most. Also FL requires everyone attending a tournament including Florida Classic to get a
 tournament-only pass. Darius also stated that he has only seen 3 claims from the tournamentonly pass over the years. Risk is very minimal.
- First Year Leagues Update OCASL is still playing.
- New League Update none.

Competitions

- Carolinas Cup Registration deadline is 11/14. There are currently 66 teams registered. Anticipate over 70 and possibly 74. There are a couple brackets that need additional teams to complete those brackets. Working with the refs. Also working on meals for refs and looking to use Fusion vendors. There are going to be food trucks at the tournament. The viewing party for the World Cup may be in one of the meeting rooms. 2 rooms in the building will be used by the refs. Also working on getting a tent for refs with possible heat.
- Celebrate the TaTas Team from Chicago is looking to play next year. It was a big story on USASA web page. They were able to donate \$40,000 and funds were raised to cover the cost of the tournament. Total of over \$50,000 was raised.

- TeamPass the proposed new registration system was discussed. Donna read a letter from TeamPass that stated they provide great customer service, answer phones, can customize to fit your needs. They are used by 5 adult state associations. Donna spoke to most league presidents about the system and everyone seems positive, but the only concern appears to be timing issues. Trying to get the system running in December. The Board unanimously approved the motion to to use TeamPass as the state's player registration system beginning in January 2023. (See text of motion below.)
- The NCASA Budget for 2023 was discussed in great detail. A technical amendment is being
 made to update a line in the budget. A friendly amendment was made to increase Registration by
 \$2000 to \$22,000 (to cover the TeamPass expenses associated with tournament-only
 registrations) and reduce NCASA AGM by \$2000 to \$7000. Budget was approved unanimously.

Adoption of TeamPass as Electronic Registration System for NCASA and its Member Leagues

Whereas, one of NCASA's core functions is player registration, and

Whereas, NCASA does not have a current written contract with the registration system it is currently using and is no longer receiving adequate levels of customer support, and

Whereas, NCASA has researched the functionality and cost of a number of the existing registration systems currently available for adult soccer associations and leagues,

Be it resolved that NCASA approves TeamPass as the official electronic registration system for NCASA and its Member Leagues beginning with the 2023 registration year,

Be it further resolved that NCASA will cover the \$2 per player annual cost, with each Member League able to decide whether to cover the 2.9% credit card transaction fees for their players or to pass those fees on to their players, and

Be it further resolved that NCASA may enter into a contract with TeamPass consistent with the payment provisions of this motion.
