Quorum determination

Officer & Staff Reports

- President Informed Board about NCASA executive director Darius Ejlali's recent eye surgery and told Board that he would not be readily available for the next week and that a card/gift would be sent to him on the Board's behalf wishing him a speedy recover. Noted that Member League Presidents & Beer City Cup organizers would be informed. Congratulated the North Carolina teams that competed at the USASA Region III Championships and noted the teams that will be advancing to the National finals Sporting Charlotte (champion) & Wanderers FC (finalists) in Men's Over 40 and Charlotte Eagles in Women's Amateur. Thanked Scott Eisenbraun for the work he did helping NC teams prepare for the event and also congratulated Darius (as Region III director) on running a great event. Said that a motion will be brought to the Board next month asking for an appropriation to allow NCASA representatives to attend the Championship of Regions in August. Reminded the Board that they would be voting to confirm the President's appointment of Chad Garber to the position of NCASA Board Secretary. Mentioned plan to hold a Special Council Meeting on July 25, 2022, to approve the Constitution & Bylaws changes recommended by the Board.
- Executive Director No report (not in attendance due to recent surgery).
- Vice President No additional report.
- Treasurer Noted that the written Treasurer's report and financials had been circulated and that the Finance committee will be meeting in July to discuss how to optimize the investment of NCASA's reserves.

Approval of Minutes

• Minutes for the May 16, 2022, Board meeting were approved unanimously.

Growth Initiative

- Registration Report Report was provided showing registration by league year-to-date. Noted that more than 1,200 players registered in the last month and that NCASA is still on track to have 12,000 registrations before the end of the year.
- First Year Leagues Update the OCASL@TASL merger (previously unaffiliated OCASL now being operated by TASL) is going well. OCASL plays four seasons, and the league is currently playing its summer season. More than 300 players registered for the summer season, which was just a little smaller than previous summer seasons.

 New League Update – Discussions are ongoing with the pick-up group in Transylvania County. There was a chance that their affiliation application would have been ready for the Board to review at the meeting tonight, but Darius' surgery put a wrinkle in those plans. NCASA President also noted that he had recently had a conversation with someone potentially interested in forming an adult league in Wayne County and was looking to see if NCASA had resources to assist him. VP League Support Jeremy Mikell offered to provide assistance.

Competitions

- Carolinas Cup
 - Charleston, SC, Memorial Day weekend tournament was a big success. 62 teams participated, with about 15 teams from NC, 15 from outside the Carolinas, and the remainder from South Carolina. Discussions have started with a second complex due to the increasing size of the event. Darius, Alex Vidaurri, and our South Carolina Partners were thanked for making this event such as success.
 - USASA Region III Championships NC teams competed at Regionals based on their performance at the 2021 11v11 Carolinas Cup. All teams represented NC well.
 - Tobacco Road (Men's Amateur) semifinals
 - 1990 Royals (Men's Over 30) semifinals
 - Sporting Charlotte (Men's Over 40) champions
 - Wanderers FC (Men's Over 40) finalists
 - Charlotte Eagles (Women's Amateur) champions
 - Winston-Salem, NC, December 11v11 a very productive kick-off planning meeting was held on Wednesday, June 15. Goal was to present the Carolinas Cup budget to the Board for approval at the July meeting, but that may be pushed to August due to Darius' surgery. Committee has decided to put on a special World Cup watch party during the event. The committee will be asking the Board to approve a separate appropriation for this activity, and the plan will be to publicize this event during registration so that players know there will be a viewing option.
- Celebrate the TaTas Budget is being presented tonight, and the committee is on track to launch registration in July. The committee already has secured enough donations/sponsorships to cover the expected costs of the event.
- Queen City Cup Social media promotion for the tournament has started, and more promotion will be coming soon. The tournament is August 6-7. There is a Charlotte FC game on Saturday night, and group ticket purchase is being arranged for players. Prize money also will be increasing this year. The goal is to become another premier 11v11 tournament for North Carolina.
- Beer City Cup It looks like the tournament will be another huge success. This year's tournament will be the largest they have ever hosted, with 110+ teams. Individual player registrations are under way.

Old & New Business (discussions)

- SafeSport policy implementation significant progress made in having Board members and Member League Board members complete training, but there is wide compliance variation between leagues. Goal will be to have as many complete as possible and encourage holdouts. NC remains far head of most of its peers in terms of implementing the SafeSport requirements.
- D&O Policies Have reached out to leagues to make sure they do not have any concerns about policies expiring at end of year. No leagues have expressed concern at this point, but another round of outreach will be done. Treasurer Bob Kepner asked if the decision to not purchase the D&O coverage for leagues beyond this year was "definite." It was noted that no money for purchasing 2023 D&O coverage was included in the 2022 budget (policies need to be purchased in advance), but the Board can always change its mind. Executive Vice President Donna Langdon noted that we may need to consider purchasing "tail coverage" for claims relating to events that occurred in 2022 but are not filed until after the existing coverage expires.
- Phishing multiple Board members have been the subject of phishing attempts, which normally
 have taken the form of someone claiming to be the NCASA President requesting money or gift
 cards. Board members were reminded to be careful and that they can verify any such requests by
 contacting the NCASA President at his personal email and/or cell phone number, which all Board
 members have.

Additional New Business (discussions)

NCASA Council Special Meeting to approve Constitution & Bylaws – discussed intent to call a special meeting of the NCASA Council on July 25 at 7 pm to approve the amendments to the Constitution & Bylaws that the Board previously has recommended. Board members indicated that they should be available at that time. Notice will be sent to the Member League Presidents. Question was raised whether under the current Constitution & Bylaws an election for Secretary would need to occur (as the first meeting of the Council after a Secretary was appointed) or if that election did not need to be held until the regular Council Meeting in January. The language of the Constitution & Bylaws will be reviewed to determine this answer.

Celebrate the Tatas Budget – Approved Unanimously

Whereas the Board approved the Budgetary Spending Authority Policy at its February 21, 2022, meeting, and this policy requires the Celebrate the Tatas committee to present to the Board for approval a proposed budget describing how already budgeted funds of \$4,500 are expected to be spent no later than three months before the start date of the Celebrate the Tatas tournament;

Whereas the budgetary authority resolution allows the Celebrate the Tatas committee to expend funds beyond the budgeted funds up to the amount of revenues from the event, and

Whereas the June 20, 2021, NCASA Board meeting is the final Board meeting occurring more than three months before the start date of the Celebrate the Tatas tournament,

Be it resolved that the Board authorizes the Celebrate the Tatas committee to spend the already budgeted funds of \$4,500, along with additional revenues from the event (e.g., sponsorships and donations, including in-kind donations), in a manner consistent with the following proposed budget:

Carolinas Cup (11v11) - Truist Park Contract – Approved Unanimously

Whereas the Board approved a motion at its May 17, 2021, meeting recommending entering into a new multi-year agreement to host the December Carolinas Cup at Truist Park (located in Bermuda Run, North Carolinas),

Whereas that the motion required that any agreement to host the December Carolinas Cup at Truist Park would be presented to the NCASA Board for approval prior to execution, and

Whereas terms for a multi-year agreement have been reached with Truist Park,

Be it resolved that the Board acknowledges that the agreement has been presented to it for review prior to execution, and
